Consultation Arrangements (Regulation 25 and 26)

Introduction

The consultation process for preparing a Development Plan Document (DPD) is regulated by the Town and Country Planning (Local Development) (England) Regulations 2004 and further guidance is provided in Planning Policy Statement (PPS) 12 (Local Spatial Planning (2008)). The consultation procedures used by Redditch Borough Council on the Issues and Options document are thus informed and obligated by these directives.

This document gives the details of the public participation procedures associated with the Core Strategy DPD pre-submission consultation, together with details of the Council's responses to representations received throughout the pre-submission process. This approach accords with Regulations 25 and 26 of the Town and Country Planning (Local Development) (England) Regulations 2004.

On the 27th June 2008, an Amendment to the Town and Country Planning Regulations came into force (The Town and Country Planning (Local Development) (England) (Amendment) Regulations 2008). This amendment altered the previous Regulations that were associated with public consultation (detailed above). As the preparation process for the Core Strategy began before this Amendment was published, the consultation procedures are only required to be in conformity with the 2004 Regulations. However, it is considered that the public consultation that is detailed in this document is also in conformity with Regulation 25 of the Amendment.

Pre-Issues and Options consultation period 18th June 2007 and 21st April 2008

This section details the consultation and information gathering events that took place between 18th June 2007 and 21st April 2008 to inform the preparation of the Core Strategy Issues and Options Document. Although there is no statutory requirement to undertake consultation prior to the Issues and Options stage, Planning Policy Statement 12: Local Development Frameworks states that "Local planning authorities should front load the preparation of development plan documents by facilitating early involvement and securing inputs from the community and all stakeholders" (Para 4.2).

One of the key objectives of the Planning and Compulsory Purchase Act 2004 is to ensure that any interested individuals, groups or organisations are able to become effectively involved at all levels of the various local planning processes. The Borough Council's 'Statement of Community Involvement' details how the Borough Council will enable interested persons and organisations to become involved and contribute to the planning process (available at www.redditchbc.gov.uk).

During the events that took place between 18th June 2007 and 21st April 2008, consultees were asked to identify 'issues' relating to the Borough of Redditch. The outcome of these events can be viewed at www.redditchbc.gov.uk in a document entitled 'The outcome of informal consultation used to inform the Issues and Options paper'.

The issues raised have, where appropriate, informed the Issues and Options Document. Issues and Options is the first formal stage in the preparation of the Core Strategy. The document highlights the matters relevant to Redditch Borough (Issues) and the ways in which these issues can be combated through the application of planning policy (Options). Consultation on the Issues and Options took place between 9th May and 20th June 2008.

Series of Events

Approval of Local Development Scheme

Local Development Scheme No.2 was approved for publication on 26th June 2006. This timetables the preparation of Issues and Alternative Options for September 2007 – May 2008.

State of the Borough Conference

The State of the Borough Conference was held on Monday 18th June 2007 at Redditch Town Hall. The event comprised a series of talks, discussion groups and presentations. The primary purpose of the Conference was to bring together members of the Redditch Partnership and associates to explore the ways in which the Sustainable Community Strategy should be updated, as well as generating issues that could be tackled by the emerging development plan. Participants were asked to complete a questionnaire which was split into the six themes of the Community Strategy.

- · Communities that are safe and feel safe
- A better environment for today and tomorrow
- Economic success that is shared by all
- Improving health and well-being
- Meeting the needs of children and young people
- Stronger communities

Under each theme, respondents were asked to write down issues about Redditch Borough that could be considered in the development plan, along with evidence to support their responses. (A copy of the questionnaire can be seen at Appendix B).

Planning Advisory Panel (PAP) Meetings

The Planning Advisory Panel comprises Elected Members. Included in the Terms of Reference for PAP is the duty to consider all matters associated with the preparation of Development Plan documents and to make recommendations to the Executive/Full Committee. Meetings were held between 4th September 2007 and 16th April 2008 during which Members were asked to identify issues that they thought were relevant to Redditch Borough.

Local Democracy Week Event

On Monday 15th October 2007 students from local high schools attended the local democracy event at Redditch Town Hall to learn about democratic processes in Redditch Borough. Members of the Development Plans team attended and discussed with students the improvements they would like to see in Redditch Borough. The questions asked of students can be seen at Appendix C.

Meeting with the Redditch Student Council

On Wednesday 7th November 2007, a member of the Development Plans team attended a meeting with the Redditch Student Council to discuss the production of the new Core Strategy Development Plan. The Student Council was informed that both residents and stakeholders from local businesses/organisations were being invited to attend discussion panels in order to help identify planning issues relating to the Borough. Student Council members were invited to attend and all members agreed to display publicity material related to the panels at their schools.

Citizen and Stakeholder Discussion Panels

A series of citizen and stakeholder discussion panels were held between 15th November 2007 and 17th January 2008. The purpose of the discussion panels was to provide an opportunity for citizens, stakeholders and statutory bodies to identify planning issues across the Borough. Initially, six discussion panels for citizens and six for stakeholders were planned; however, due to a low response rate the decision was taken to merge some of the citizen and stakeholder groups into one session. The discussion panels were advertised in a number of ways:

- All those on the Development Plans database were written to on 14th September 2007 (either by post or e-mail) to advise them of the discussion panels (the letter can be seen at Appendix D). Also enclosed was a leaflet (Appendix E) which detailed the purpose of the sessions, who should attend, what was expected of participants, where and when the discussions panels would take place and a response form.
- An A4 sized poster was displayed on forty notice boards in Councilowned buildings across the Borough. These were displayed from 14/09/07 – 29/10/07 (Appendix F)
- A display with supplementary leaflets was accommodated at Planning Reception in Redditch Town Hall from 14/09/07 – 29/10/07.
- A press release appeared in the 'Redditch Standard' on Wednesday 26th September 2007 inviting residents and stakeholders to join the discussion panels. (Appendix G)

Planning Information Day - Thursday 10th April 2008, 10am - 9pm, Redditch Town Hall

This event was held to give local residents and anyone interested in planning the opportunity to find out about the planning process in Redditch Borough. A presentation which introduced the Issues and Options consultation process was given at 11am and repeated at 1pm, 3pm, 5pm and 7pm. Attendees were informed of the purpose of the consultation and the dates that it was taking place. The event was advertised in the following ways:

- Press releases appeared in the Redditch Standard, Friday 4th April 2008 and Redditch Advertiser Wednesday 9th April 2008. (Appendix H)
- Local residents, businesses and organisations on the Development Plans database were sent an A5 postcard inviting them to the event. (Appendix J)
- An A4 poster was displayed on forty notice boards in Council-owned buildings across the Borough (Appendix K).

Continued consultation

On Friday 2nd May, Development Plans Staff (John Staniland and Ruth Bamford) along with Officers from the Communications department gave a media briefing to local press, including The Advertiser Newspaper and Touch FM. The intention of the media briefing was to provide the local press with an overview and understanding of the Issues and Options consultation period and the Sustainable Community Strategy consultation period. A presentation was given and an opportunity was provided for questions and answers.

Issues and Options consultation period 9th May and the 20th June 2008

Introduction

The Core Strategy Development Plan Document 'Issues and Options' has been produced by the Borough Council to inform the development of Redditch Borough's Core Strategy – a key document in the future of the Borough. This Issues and Options Document highlights the matters relevant to Redditch Borough (Issues) and the ways in which these issues can be combated through the application of planning policy (Options).

In accordance with Redditch Borough Council's Adopted Statement of Community Involvement (SCI), the consultation process undertaken satisfied all of the minimum requirements of the SCI. The sections below outline the public consultation that was undertaken in conformity with the SCI.

The Issues and Options document was placed on deposit for public consultation between the 9th May and the 20th June 2008. During this period interested parties were asked to submit comments via a questionnaire. This questionnaire and the Issues and Options full document were available at various locations, specified in the ensuing section 'Document Availability'. All the questionnaires and comments received were responded to by officers and presented to the Council (see Appendix L).

In order to ensure that the DPD conformed to the consultation requirements of the SCI, the following pages detail the consultation that was undertaken.

Consultation on the Sustainable Community Strategy

The Core Strategy is required to have strong links with the Borough's Sustainable Community Strategy. The Sustainable Community Strategy creates a long-term, sustainable vision for the Borough and determines local priorities. These priorities are based on a County-wide document called the Local Area Agreement.

The Sustainable Community Strategy is prepared by the Local Strategic Partnership. The 'Redditch Partnership' brings together the views of the local private, voluntary and community sectors to prepare and then implement the Sustainable Community Strategy for Redditch Borough. The draft Sustainable Community Strategy was placed on consultation at the same time as the Core Strategy Issues and Options document (9th May – 20th June 2008). The intention of this 'joint' consultation period was to prevent consultation fatigue for the general public, to ensure the public responded to the document they felt most appropriately dealt with their circumstances and to increase the availability of staff and budget resources to carry out effective consultation.

Series of events

Posters

Newspaper articles

Two articles were issued during the consultation period. One appeared on the 9th May 2008 in The Standard, entitled *'Have your say on how to develop the town'* and another on the 30th May 2008 in The Standard, entitled *'Town's blueprint for a safer future'* (A copy of these articles can be seen in Appendix S).

Advert

An advert was placed in The Standard on Friday May 2nd 2008 (the advert is the same as the poster and can be seen at Appendix R).

Correspondence

Letters/ emails were sent to all statutory consultees and all parties that the Borough Council considered to have an interest in the Issues and Options Document. The correspondence detailed the role of the future Core Strategy and all of the consultation activities known at the time (a copy is attached in Appendix U). (On 31st January 2006 a letter was sent to everyone on the Council's consultation database asking which documents scheduled for production in the Local Development Scheme they wished to be consulted on. Everyone who requested to be consulted on the Core Strategy DPD was sent a letter).

Consultation calendar

The consultation period for the Sustainable Community Strategy and the Issue and Options Consultation period were scheduled on Worcestershire County Council's online consultation calendar for the duration of the consultation period. The Consultation Planner and Finder bring together information about public consultation undertaken by Worcestershire County Council and other organisations.

Conclusion

There is a statutory requirement to undertake pre—submission consultation prior to the submission stage. The Borough Council has found the early consultation, using a variety of methods, a useful tool for identifying some planning issues that need to be addressed in the Borough up to 2026 and giving the public the opportunity to consider the best approach for dealing with the identified issues. Offering a diverse and continued consultation opportunity has added considerable value to the development of the Core Strategy so far. The Council is grateful to all stakeholders and residents who have generously given their time.

Please find below details of opportunities to have your say on two new planning documents – the Core Strategy Development Plan Document and a Supplementary Planning Document on Affordable Housing. There are also details of six Supplementary Planning Documents that have recently been adopted by the Council.

Your chance to have a say on the future of planning in Redditch Borough

The Development Plans team is working on the Core Strategy Development Plan Document (DPD). This forms part of the Local Development Framework (LDF) for the Borough and will be the main planning document for the Borough up to 2026. The first stage in the production of the Core Strategy is to identify planning issues that relate to the Borough of Redditch.

The leaflet enclosed has information on how you can get involved by taking part in one or more of our citizen or stakeholder discussion panels. This is your opportunity to tell us what you think are the planning issues in your local area and across the Borough.

We want as many people as possible to join the discussion panels and we look forward to meeting you there.

Affordable Housing Supplementary Planning Document (SPD) Consultation

The Borough Council has prepared a Draft SPD - Affordable housing provision for public consultation. The consultation period will begin on 5th October 2007 and run until 16th November 2007.

The Draft SPD originally went out to public consultation 31 October-12 December 2006. However, during this time a number of key documents were published (these include PPS 3 'Housing', the Code for Sustainable Homes and the Design and Quality Standards). The Council considered it important to include the provisions of these documents within the SPD in addition to other suggested changes as a result of public consultation and other minor amendments. As these changes overall are substantial to the document, it is necessary for the SPD to be subject to another period of public consultation.

The revised Affordable Housing Provision Draft SPD sets out the Borough Council's negotiating position for affordable housing and draws attention to the areas in need of consideration when applying for a housing scheme.

Copies of the Draft SPD are available for inspection at the locations detailed below. Hard copies are also available on request from the Development Plans team.

Should you have any queries about these matters or require any further information regarding the SPD, please contact Louise Brockett (Development Plans Team).

We are inviting comments on the Draft SPD which must be received no later than 5pm on 16th November 2007 and should be sent in writing to John Staniland at the Development Plans Team at the address on the letterhead.

Adopted Supplementary Planning Documents

The Council has now adopted six Supplementary Planning Documents (SPDs). Each SPD provides more detailed guidance and information on policies within Local Plan No.3 (adopted May 31st 2006) (Local Plan No.3 covers the whole of the administrative area of Redditch and sets out detailed land use policies which guide development).

Each SPD was subject to a statutory six week consultation period; a summary of the responses received and the Council's response can be viewed alongside the SPDs at the locations listed below.

The six SPD's are as follows:

- Church Road, Town Centre (Formally known as the North West Quadrant). This SPD provides more detailed guidance on issues contained in the Borough of Redditch Local Plan No.3 Policy E(TCR).6. 'North West Quadrant'. Specifically the SPD is a development brief to inform and guide development within the Church Road site.
- Church Hill District Centre Development Brief. This SPD provides more detailed guidance on issues contained within the Borough of Redditch Local Plan No.3 Policy E(TCR).9. 'District Centres' and E(TCR).10. 'District Centre Redevelopment'. Specifically the SPD provides a planning policy framework for the possible re-development of Church Hill District Centre.
- Edward Street. This SPD provides more detailed guidance on issues contained within the Borough of Redditch Local Plan No.3 Policy E(EMP).5 'Edward Street Site'. Specifically the SPD has been prepared in order to provide planning and urban design guidance for the future re-development of the Edward Street site. It is hoped that re-development of the site will make the "gateway" to Redditch more attractive to train passengers.
- Land to the Rear of Alexandra Hospital Development Brief. This SPD provides more
 detailed guidance on issues contained within the Borough of Redditch Local Plan No.3
 Policy E(EMP).1. 'Employment Provision'. Specifically the SPD has been prepared in
 order to guide the development of employment site IN 69 under Local Plan No.3. A
 parcel of land to the rear of the Alexandra Hospital is designated for two hectares of
 employment land.
- Open Space Provision. This SPD provides more detailed guidance on issues contained within the Borough of Redditch Local Plan No.3 'Provision of Informal Unrestricted Open Spaces', R.4 'Provision and Location of Children's Play Area's' and R.5 'Playing Pitch Provision'. Specifically the SPD provides detailed guidance on the relevant level of planning obligations to be sought from developers in relation to new housing developments. It is anticipated this SPD will be applied to all new developments across the Borough.

• Prospect Hill, Town Centre. This SPD aims to guide re-development of the Prospect Hill site. It provides more detailed guidance on issues contained within the Borough of Redditch Local Plan No.3 Policy B(HSG).1. 'Housing Provision'. Specifically the SPD has been prepared in order to guide the development of a reserve housing site identified for possible residential development in the Borough of Redditch Local Plan No.3. The site is brownfield land in private ownership and has the capacity for 61 dwellings.

Consultations on town's future get under way
